Introduction & background

Updated to reflect the changes made:

- the use of the terms 'allegations and suspicions' rather than disclosure to more accurately describe the process and correspond with the terminology of the Social Services and Well-being (Wales) Act 2014
- links made to the Regulation and Inspection of Social Care (Wales) Act 2016 and Social Care Wales.

Unchanged, but workbook terminology changed to use 'suspicions' and 'allegations'.

Extension resources withdrawn and to be replaced by a comprehensive signposting list from Social Care Wales.

Practice reviews

Introductory information is provided for trainers called *Concise and extended practice reviews (Wales)*.

Reviews have a common template to give consistency with an introduction about how to use them and links to the full review information, if still available.

Three new reviews have been added to provide recent Welsh examples that complement the range of situations for training and discussion. These are Operation Jasmine, Child DS and Child M.

Three have been removed as they were not proving useful for discussion and/or were not providing clear information. These are Jimmy Saville, the Francis report and Harold Shipman.
