

# Table of qualifications required for social care managers and workers working in Domiciliary Care Agencies in Wales

## Domiciliary Care Manager

You must be registered with Social Care Wales in order to practice as the registered manager in a domiciliary care agency in Wales. To register you must hold one of the qualifications listed below. The regulations require that people nominated to deputise for a registered manager must also be qualified as a domiciliary care manager and register with Social Care Wales. Holders of any other social care qualification deemed by Social Care Wales or by a Care Council to be equivalent to those listed in this Schedule shall be regarded as having completed the training requirement for social care workers in respect of the description of social care work to which the requirement relates for the purposes of sections 84(b) (ii) of the Act.

To register you must hold one of the qualifications listed below. All domiciliary care workers must register with Social Care Wales by April 2020.

If you are applying for registration before 2020 there are two additional routes which can be used. These are listed at the bottom of this document.

## Applying for registration as a domiciliary care worker before April 2020

Between April 2018 and April 2020, you can register with Social Care Wales on a voluntary basis. To do this, you must either hold one of the qualifications listed in the table above or apply to register by either:

**a)** holding the Level 2 Award for Social Care Induction (Wales)

*or*

**b)** if you have three or more years continuous experience of working in the sector, a statement of competence that has been signed by your registered manager and is supported by evidence of relevant knowledge and skills.
